CONTRACTED LESSON TIME AND LESSON PACKAGE LENGTH

By signing up for lessons at (your studio's name), you are reserving a consistent weekly lesson slot that is held exclusively for your lessons during a 16-week lesson term in the fall and 16-week lesson term in the spring. Tuition for the lesson terms may be paid with a half payment, full payment, or monthly payments. If paying monthly, tuition is due the first week of each month via credit card or PayPal. Students will be sent an automated email invoice with payment link prior to each payment due date.

SUMMER SCHEDULE

Flexible scheduling is available during the summer to accommodate vacations and other activities.

DISCONTINUING LESSONS

The teacher reserves the right to dismiss a student based upon repeated cancellations, irregular attendance, inadequate preparation, or late payment of fees.

SHEET MUSIC AND MATERIALS

It is up to the student to purchase sheet music, books, and other materials. Names of music retailers and websites for purchasing hardcopy sheet music will be provided by the teacher.

MAKE-UP LESSON POLICY

Make-up Lessons: If a student misses a lesson for any reason, the studio is unable to provide a refund or credit. It is the studio's strict policy that no refunds are offered or provided for lessons missed by a student. Due to the high volume of students taught by the teacher, make-up lessons are also not available. There are no exceptions to this policy.

Video Lesson Alternative: As an alternative to a missed lesson, students may send a video of their playing prior to their normal lesson time. The teacher will provide written or video feedback during the scheduled lesson time.

Holidays: The studio closes during some, but not all, holidays. Important dates can be found on the studio calendar. Holidays are excluded from each student's tuition and no make-up lessons are required for these dates.

Missed Lessons by the Teacher: It is the teacher's responsibility to be present for every lesson. If the teacher misses a lesson for any reason, a make-up lesson or refund will be given.
